

# SERVICE AGREEMENT

Between

Saratoga Union School District

and

The Silicon Valley Mathematics Initiative, LLC



This document is to serve as an Agreement between Saratoga Union School District and the Silicon Valley Mathematics Initiative, LLC (SVMI). The effective dates of this Agreement shall be March 12, 2019. This Agreement may be extended upon mutual written agreement of the parties.

## 1. Service Deliverables

SVMI will provide:

- Performance Tasks scoring services for the 2019 MAC/MARS performance assessments. (Approximately 955 exams from 5<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup>, 8<sup>th</sup>, Algebra 1 & Geometry)
- Please note that data input, manipulation, or management is not included in this MOU.

Saratoga will provide:

- the unscored work in file folders in groups of 20.
- the unscored work to SVMI by or on March 24, 2019.

## 2. Funding and Payment

SVMI, LLC shall invoice Saratoga Union School District after March 30, 2019. Saratoga Union School District shall pay SVMI, LLC an amount not to exceed a maximum amount of \$10,800.

## 3. Indemnification

Saratoga Union School District and SVMI, LLC mutually agree to indemnify and to hold harmless the other party from damage to persons or property resulting from any act or omission on the part of each party, its employees, agents or officers.

## 4. Termination

Either Saratoga Union School District or SVMI may terminate this Agreement by giving thirty (30) days written notice to the other party. Saratoga Union School District shall reimburse SVMI for acceptable and allowable work performed under this Contract, and for all non-cancelable obligations made in connection with such work, through the date of

termination. All related data that has been transferred shall be destroyed, deleted, or otherwise removed from SVMi computers and servers.

**5. Entire Agreement**

This Consulting Agreement and the Attachment hereto constitutes the entire agreement of the parties concerning the services described herein.
